In continuation of this office letter cited, we are providing herewith data pertaining to each employee in separate **e folder**, created in the name of each eligible retired/serving employee of KSCARD Bank for serving the purpose of uploading data subject to acceptability of the same by EPFO for getting higher wage pension based on actual salary, as per Hon'ble Supreme Court judgement dated 04/11/2022 in SLP Nos. 8658, 8659.

The data made available in **e folder** are noted below.

- 1) 26(6) statement prepared consistent with exempted trust deed of KSCARD Bank. (250 kb size).
- 2) Joint option filed earlier by employees as per judgement of Hon'ble High Court of Kerala/Hon'ble Supreme Court for remitting higher contribution to EPFO based on actual salary. (250 kb size), of whom, which is available with the Bank.
- 3) Abstract of PF register showing fund balance as on 31/03/2023 of eligible serving employees (250 kb size).
- 4) Form of an Undertaking to be filed by eligible retired /serving employees, if they have no balance /insufficient balance in PF account of Employees Provident Fund Trust of KSCARD Bank at the time of filing on line application.

The employees, who have to file the undertaking (as per para 4) have to prepare the same in a Rs.200/- worth non judicial stamp paper and upload it as 250 kb size document.

It is also requested that, before uploading data in EPFO portal, please ensure correctness of Name, UAN, Date of entry in service /Date of retirement from service of the Bank etc. It is the discretion of an employee to utilise all data or any of the data provided in it by the Bank.

All Regional Managers are advised to inform the same to all eligible retired / serving employees in the region and provide **e folder** in time to eligible retired/serving employees of the Bank in their email id after obtaining email id of the eligible employee.

It is also informed that, it is the duty of each eligible retired/serving employee to upload relevant data requested by EPFO to EPFO portal personally within the time frame fixed by EPFO in it. If any difficulty is experienced while uploading data to EPFO portal, please contact Programmers of EDP section in Head Office or System Administrators in near by Regional Offices of the Bank for necessary assistance.

We expect positive action from EPFO in this regard.
